Meeting #23 Summary – Leslie Surprenant

ISC accepted meeting summary.

ISAC Update – Meredith Taylor (2 Handouts)

Meredith Taylor is new chair of ISAC. Provided final 2014 ISAC report. ISAC discussed 2015 priorities at its 11/24 meeting and requests a joint ISAC/ISC meeting. ISAC's 2015 initiatives are:

- Education and outreach on Part 575 Invasive Species Regulations (Prohibited and Regulated Invasive Species)
- Assist in developing an early detection / rapid response list and protocol
- Continue 2014 initiatives

- o Public Awareness Poll
- o NY IS Awareness Week
- o Invasive Species “Bookshelf”

IS Awareness Week July 12-18

Workgroup members formed PRISM leaders, NYISRI coordinator, and Cornell Cooperative Extension) is planning the 2nd annual NYISAW

Public Awareness Poll – Chuck O’neill (2 handouts)

Two-part study underway is being conducted by Cornell under its statewide Education and Outreach contract with DEC to determine level of awareness and knowledge of IS. The first part screened 3400 NY residents to determine awareness and second part (currently underway) re-surveys willing individuals who self-identified as anglers, boaters, campers, hikers or gardeners to measure the relative importance of IS as a concern compared to other issues and what, if any, actions those individuals take to prevent the spread of IS. Null hypothesis was that NY’s citizens would have a low level of awareness and knowledge. Results: 74% have some awareness and 1/3 indicate they “know something” about. More information about the study and the Phase 1 report is in a link from this Clearinghouse webpage: http://www.nyis.info/?action=isp_reports The final project report with recommendations is expected to be completed by the end of May prior to the contract end date of June 30, 2015.

Mission Statement – Kathy Moser

A Council mission statement was unanimously adopted by the Council. The Council’s Mission is “to foster collaboration and coordination among State agencies, the New York Invasive Species Advisory Committee, and stakeholders across the State to minimize the harm caused by invasive species to New York’s environment, economy, and human health.”

Regulatory and Legislative Updates – Chris Logue, Dave Adams

USDA APHIS has quarantined all of NYS for Emerald Ash Borer. DEC and DAM are working on an infestation-based quarantine that will better protect the majority of NY’s geography that has not been identified as EAB-infested. New NYS regulation should take effect 5/1/15.

Part 575 (Prohibited and Regulated Invasive Species) – Nursery trade and pet industries have worked closely with DAM and DEC and developed labels for regulated species and have shared with their constituents online for download. Cultivar exemptions: a cultivar assessment team was formed with agency, industry, academia, and conservation interests represented. A cultivar assessment tool developed by a team of experts in the Long Island PRISM was recommended by the statewide assessment team and adopted by the ISC at this meeting. The assessment team reviewed cultivars of 7 Japanese barberry for potential exemption from prohibition and has recommended 4 Japanese barberry cultivars for exemption (“Aurea”); however, only 1 will be listed in the State Register because trademark names for 3 cultivars have

not been registered. The team also assessed 2 cultivars regulated species that would provide alternatives to IS: Wintercreeper (*Euonymus fortunei*). (Editor's note: these cultivar exemptions and 1 Chinese Silver Grass (*Miscanthus sinensis*) (regulated) will be listed in the ENB and State Register on 5/20/15)

AIS Boat Launch Law – Passed and signed by Governor. DEC staff are working on regulatory language for “reasonable precautions” (new Part 576) needed to slow the spread of AIS by boating. Divisions of Lands and Forests and Fish, Wildlife and Marine Resources are coordinating stakeholder engagement. The regulations will take effect in the fall (date TBD).

Guest Discussion on Hemlock Woolly Adelgid (off agenda lunch time discussion) – Mark Whitmore
Mark discussed control tools for HWA (chemical and biological control) and his interest in identifying statewide priorities for protecting significant hemlocks and hemlock stands with a focus on keeping HWA this ecologically-critical species, especially in the Adirondacks. He is researching development of insectaries in hemlock hedges to rear biological control beetles to reduce the cost of applying biological control.

Priorities / Action Plan – Dave Adams (Handout)

Council accepted 2015 Action Plan with the addition of initiating an HWA working group and supporting bio-control research on HWA.

ACTION ITEM– ISCU set up meeting on priority setting with NYISRI, PRISMs, CCE. (Done - NYISRI hosted priorities setting workshop with 2 contract facilitators, PRISM leaders, iMap, CCE, and ISCU at Cornell University on 4/22-23)

AIS Management Plan team reviewed comments and is working on finalizing plan (Editor's note: final plan is on DEC's final internal review routing as of 5/4/15)

Meeting #24 Summary – Leslie Surprenant
ISC accepted meeting summary.

ISAC Update – Meredith Taylor (*1 Handout*)

Provided update; reiterated items reported at last ISC meeting held 1/29/15 (2014 annual report, 2015 priorities, request a joint meeting); reported on 3/31/15 ISAC meeting and upcoming Education and Outreach Committee meeting topics. E-O committee will be discussing:

- Best use of the public awareness survey
- Increasing participation in ISAW
- Increasing inclusion of IS topics in K-12 curriculum
- Best way to support E-O for NY's new invasive species regulations (Part 575 prohibited and regulated invasive species)
- Reviewing needs for next E-O and Clearinghouse contracts

Southern Pine Beetle – Jessica Cancelliere

Informed, updated ISC on status of SPB on long island and control strategies. Next steps are inventory and hazard assessment for infestation on DEC and County-owned properties. New find in Shirley, CT. Treatment will be spot suppression winter 2015-16; possible forest thinning; cut and removal is best, but not feasible.

Action: Send synopsis and information for accessing maps to Leslie for distribution to ISC (Jessica Cancelliere - Done)

Enacted Budget and Proposed EPF Spending Plan – Leslie Surprenant (1 handout)

Enacted budget for State Fiscal Year 2015-16 EPF IS line is \$5,700,000 (increased \$1,000,000 from SFY 14-15) and includes carveouts for Lake George (\$450,000) and IS control including grants (\$1,000,000). Governor directed \$1 M to support a pilot boat inspection and decontamination program in the Adirondacks to be implemented by the start of 2015 boating season. Presented projected contractual and new spending expenses for current SFY (total \$6,027,000). Spending plan includes all implementation projects and contracts and reserves \$100,000 for response. Current spending uses unspent and re-appropriated funds from prior SFYs.

Regulatory and Legislative Updates – Chris Logue, Dave Adams, Leslie Surprenant
Revised Emerald Ash Borer Quarantine - USDA APHIS quarantined all of NYS for Emerald Ash Borer; oversees the movement of ash regulated articles in interstate and international commerce. DEC and DAM are working on an infestation-based quarantine to better protect most of NY not yet known to have EAB. DAM filed revised Part 141 EAB regulations on 5/11/15 with the Department of State. Revision establishes 14 restricted zones which include EAB-infested areas and a five mile buffer zone. The boundaries will be revised each winter to reflect trapping and survey data. Free movement of infested materials within the new boundaries without compliance agreements or permits is allowed and the revision will make it easier for municipalities, homeowners, and industry to remove, treat and dispose of infested materials. Revised regulations will help slow the spread and give un-infested communities time to plan management. DEC has proposed parallel Part 192 quarantine regulations and is accepting public comment through 4:00 PM on 7/11/15 (see <http://www.dec.ny.gov/regulations/2359.html#part192>)

General Permits –

DEC published in the 5/13/15 State Register draft GPs for removing aquatic invasive species under Article 15 Stream Protection and Article 24 Regulated Wetlands permits using hand harvesting, suction-assisted hand harvesting, and benthic mats; public comments are accepted through 5/29/15.

APA published a proposed in the 4/23/15 State Register new GP to support rapid response and containment of new populations of AIS by permitting management by hand harvesting and benthic mat placement on up to ½ acre of AIS under Article 24 Regulated Wetlands and APA authorities; public comments accepted through 5/29/15. APA also proposed re-issuance of a GP from 2008 for managing invasive terrestrial

plants using best management practices including herbicides in or within 100 ft of wetlands in the Adirondack Park and provides for expanding the list of organizations authorized to work under the revised GP; public comments accepted through 5/29/15.

AIS Spread Prevention / Boat Transport Law – Part 576 “Reasonable Precautions” regulations – DEC staff met with Empire State Marine Trades Association to hear the organization’s concerns about the law; staff crafted draft regulations that are under Executive review. Draft regulations should be out in a few weeks and final regulations should take effect in the fall.

AIS Spread Prevention / AIS sign law – Revised Navigation Law Article 3 §35-d; requires DEC to design and post online downloadable universal AIS sign; requires “owners of each public boat launch” to “conspicuously post” these signs of at least 18” x 24” by 9/23/15.

Action: Send link to text of law to ISC (Dave Adams - Done)

Part 575 Lists of Regulated and Prohibited Species Regulations – (1 Handout) provide for allowing cultivars that are “completely sterile” and acceptable cultivars are to be published by the DEC in the State Register and Environmental Notice Bulletin. A cultivar assessment tool was developed by a Long Island scientific advisory team and adopted by the Council at its Meeting #24 (1/29/15). An interdisciplinary cultivar assessment team reviewed cultivars of 7 Japanese barberry (*Berberis thunbergii*) for potential exemption from prohibition and has recommended 4 Japanese barberry cultivars for exemption (“Aurea”); however, only 1 will be listed in the State Register because trademark names for 3 cultivars have not been registered. The team also assessed 3 regulated species cultivars that would provide alternatives: 2 Wintercreeper (*Euonymus fortunei*), 1 Chinese Silver Grass (*Miscanthus sinensis*). DEC published a list of accepted cultivars on 5/20/15 in the State Register and Environmental Notice Bulletin (http://www.dec.ny.gov/enb/20150520_not0.html)

Education-Outreach – Leslie Surprenant, Dave Adams (1 handout)

Cornell statewide poll Phase 2 (follow up interviews) is complete and report will be done shortly. Cornell’s contracts for online Clearinghouse expired 12/31/15 and statewide education-outreach contract expires 6/30/15. Leslie recommended an assessing the program, considering recommendations in Cornell’s reports, and defining desired objectives for E-Othe next 5 years. ISCU needs staff to oversee the project and any contract procurements needed. ISCU should have 2 contract employees from SUNY ESF within a few months; 1 to coordinate education-outreach coordinator and the other to coordination response and management. Recommended a small subcommittee of ISC, ISAC, PRISM to assess results, needs, and develop objectives for next 5 years and recommend to ISC ISC consideration.

Dave presented “Play, Clean, Go,” an outreach program aimed at preventing the spread of terrestrial invasive species through hiking activities and incorporating boot cleaning stations that has been proposed to be implemented in the Finger Lakes Prism in cooperation with several PRISM partners. Discussed and ISC expressed support and potential uses within agencies. APA (Ed Snizek) suggested piloting in the Adirondacks. The FL PRISM is ready to implement in the FL region. Decision: await SUNY ESF education and outreach coordinator for implementation beyond PRISM.

IS Awareness Week - July 12-18

ISAW work group (DEC lead; PRISM, Cornell Coop Extension, Research Institute); Governor’s Proclamation in process; theme is “Alternatives to Invasive Plants” in gardening and landscaping linked with Part 575 Regulations. Subtheme is “Partnerships.” Possible statewide event yet to be determined.

Howard announced his departure from CC and CC's representative will be Mark Miller. Howard is taking a position at the NY Power Authority; ISC thanked him for his nine years of engaged and productive participation on the ISC and welcomes Mark.

ISAC Update – Meredith Taylor (*1 Handout*)
Provided update on 5/8/15 ISAC Education and Outreach Work Group call; highlights/recommendations

2014 Initiative Review:

- ✓ ISAW slogan and logo should be available to all on partner websites (currently on Clearinghouse; Holly Cargill-Cramer / NY Nursery and Landscape Industry can host (Clearinghouse will be up until at least 6/30/16).
- ✓ IS Bookshelf – will remain on Clearinghouse until at least 6/30/16; ISCU should maintain access to/ copies of all publications; publications should remain available
- ✓ Awareness Survey – Meredith and Holly C will review final report to inform ISAC's recommendations to ISC on next education initiatives
- ✓ IS Awareness Week – ISAC desires higher participation in 2015 and a focus on using native plant available in trade as alternatives to prohibited and regulated plants

Review of ISAC Education and Outreach Plan

NYS Education is one of 9 statutory agencies on ISC, but has not been represented; would provide much-needed NYS education perspective.

Adirondack Park AIS Spread Prevention Pilot Program – Jeff Sann (Paul Smiths College)

Presentation on Governor's initiative to establish a pilot program to increase the number of boat stewards in the Adirondacks and provide boat decontamination stations boaters can use

on a voluntary basis. Stakeholder interest in increasing such programs in the Adirondacks and statewide. DEC purchased 9 hot water high pressure units and one large trailer-mounted recirculating unit for the program. A representative of Landa pressure washers demonstrated the equipment.

Part 575 Regulations – Prohibited and Regulated Species – DAM inspectors are observing good effort to comply with regulations; outreach to “chain” stores is more difficult because the store does not own the plant stock that it sells.

Education-Outreach – Chuck O’neill

Cornell statewide poll and report is complete and will be posted on Clearinghouse website. Self-identified groups in the initial phone poll that has sufficient sample size for follow-up questions in “Phase 3” were: farmers, aquaria owners, and water gardeners.

Study assumption: many New York residents would know little about IS. Conducted 3-part study: 1. initial screening survey to identify those with some level of awareness of IS. 2. Follow-up survey of these individuals to measure their concern about invasive species, and their invasive species-related behaviors. 3. Interviews of members of three key stakeholder groups to characterize the experiences and perspectives related to invasive species of three key stakeholder groups: farmers, aquarium owners, and water gardeners.

Part 3 phone interviews covered

- Concern about invasive species
- Knowledge about invasive species
- Behaviors that contribute to or limit the spread of invasive species
- Willingness to change behavior to reduce the spread of invasive species

- Types of messages or arguments most likely to encourage them to change their behaviors to limit the spread of invasive species

Common across the 3 groups were:

- Many people in all three groups were at least somewhat concerned about IS
- Few considered themselves knowledgeable about IS
- Farmers most knowledgeable as a group
- Individuals in all three groups thought about invasive species differently than how we define them, viewing them as problem species (e.g. deer, coyote) rather than necessarily non-native problem species
- Vast majority of interview respondents were aware of ways that people could spread invasive species, particularly by recreational boats
- Fewer knew they could be spread in firewood

Recommends future study to measure changes in knowledge and behaviors every 3 – 5 years.

NYS Dept. Environmental Protection – table at farmers’ markets on alternatives to invasive plants; working with Cornell Coop. Extension and PRISM partners on terrestrial and aquatic IS outreach

Audubon NY – Invasive species pulls, native plant classes

Biodiversity Research Inst./SUNY Albany – presentation on changing forests at Huyck Preserve

PRISMs – many PRISM events; PRISMs partnering with DEC and OPRHP on some events

- St. Lawrence – E. Lk. Ontario hosting 2 events (citizen science and exhibit on riparian IS); working with other DEC and other partners on activities
- APIPP – several events including AIS surveillance in backcountry waters training, Best Mgt Practice (BMP) training, and Native and non-invasive plant alternatives

CC – waterchestnut pull (Oswego R. / Onondaga R.)

TA – hosting DEC-staffed table at New Baltimore Service Area on alternative to prohibited and regulated plants

OPRHP – several events: IS walks, BMPs, mile-a-minute pull, hemlock wooly adelgid survey

DOT – internal training, website connections to PRISMs and other partner webinars, implementing a “Work, Clean, Go” BMP protocol at maintenance facilities

DEC – events hosted by all regional offices; most partnering with PRISM

Other Updates:

TA – reviewing planting plans and recommendations; recommend native plants as first choice; updating guidance for project development for controlling, removing, and disposing IS

CC –

- Champlain basin separation feasibility study agreement with US Army Corps of Engineers (ACOE) nearly final; signed agreement with Lk Champlain Basin Program and New England Water Pollution Control Commission (NEIWPCC)
- CC and ACOE treating Tonawanda/Erie canal hydrilla week of 7/20-24

DEC – executive briefed on hydrilla in Croton R; next step is to determine whether hydrilla has expanded to Hudson River; task force investigating treatment options

Public Comment – All

Rob Williams– conveyed comments and concerns from PRISM leaders

- WNY PRISM –cost of maintaining commercial pesticide permit for NGOs; need to have non-commercial / non-business option
- L. Hudson – wants statistics provided on nursery compliance with Part 575 Regulations
- Long Island –
 - Terrestrial invasive species should get equal attention and funding as aquatic invasive species
 - Governor’s office is trying to find \$1M for southern pine beetle infestation control on Long Island

Polly Weigland

Suffolk and Nassau Counties have “do not sell” laws in place (predate Part 575 Regulations); Suffolk not implementing and enforcing its law due to Part 575 Regulations
